Rodriguez serves as Executive Director of the Philadelphia Land Bank (PLB) and the Senior Vice President of Land Management at Philadelphia Housing Development Corporation (PHDC), appointed in 2017, and Deputy Executive Director of the Philadelphia Redevelopment Authority (PRA) appointed in 2019.

The Land Management group is responsible for the acquisition, disposition and property management of surplus real property for PLB, PHDC & PRA including the surplus inventory of the City of Philadelphia's Department of Public Property. Since 2018, Land Management has disposed of land resulting in 744 units of housing, 56% of those units were affordable housing units. Land Management has also acquired 772 parcels of land through Sheriff Sale.

Previously, Angel served as Vice President of Community Economic Development (CED) for Asociación Puertorriqueños en Marcha (APM). APM a Philadelphia based non-profit, assists families achieve their full potential through innovative housing & community development programming. Angel was responsible for housing development initiatives and directed the Sustainable Communities Initiative (SCI) Quality of Life Plan for Eastern North Philadelphia. He established APM's Food Buying Club which focused on food insecurity in Eastern North, oversaw community outreach, Housing Counseling, and APM's Financial Opportunity Center (FOC).

Angel's 32 year career began in education, establishing an alternative school for adolescents with special needs then serving as the Executive Director of Youth Build Philadelphia Charter School, one of the first six charter schools established in the state of Pennsylvania, serving out of school youth and building affordable housing. Angel focus then shifted to Community Economic Development (CED) developing holistic programming for at risk communities. His work in CED began with serving as Executive Director of the Empowerment Group a not for profit focused on small business development and entrepreneurship training in Philadelphia. It continued with his facilitation of Entrepreneurship Training at the Corzo Center for the Creative Economy at the University of the Arts. Currently, Angel serves as Chairman of the Board for the Food Trust.

While completing his Master's Degree from The American University in Cairo, Egypt, Mohamed (Mo) Rushdy began his construction engineering career with a position as a Planning Engineer on the construction of the first-ever cement plant in Sinai, Egypt. He then moved to Kuwait for two years, where he served as the planning and project controls Engineer for the construction of Kuwait's first Olympic stadium.

Rushdy moved to the United States in 2004 and worked with Toll Brothers as a Sr. Project manager in its largest urban project at the time: Naval Square. In early 2007, Rushdy was recruited by Westrum Development Company, as General Manager to launch, contract and hire a team for Philadelphia's largest active adult community: The Arbors at Eagle Pointe, consisting of approximately 400 homes.

In late 2008, as the financial crisis unfolded, Rushdy joined Larry McKnight, a colleague from Westrum, to start developing single lot infills in Philadelphia's Fishtown neighborhood. Their investments in the area have contributed to the revival of the city's river wards neighborhoods - Kensington, Fishtown, Northern Liberties, Port Richmond, and others.

Now nearly 12 years later, what started as five homes per year in 2012 has grown to hundreds of homes under construction of mostly naturally occurring affordable housing. The Riverwards Group, where Rushdy serves as Managing Partner, has completed more than 60 projects in Philadelphia's booming riverwards neighborhoods, totaling close to 600 mainly single-family homes delivered over the decade. The Riverwards Group has about 1,100 units in construction and approval process combined.

In 2017, The Riverwards Group was named to Philadelphia magazine's list of the "next wave of Philadelphia developers," which highlighted nine developers remaking the city's neighborhoods in big ways. In addition to Philadelphia magazine, the company and Rushdy were featured in articles in The Philadelphia Inquirer, Philadelphia Business Journal, Curbed Philly and Spirit News.

Rushdy serves as Board President of the 420 member company Building Industry Association of Philadelphia, and is on the board and the Chair of the Philadelphia Accelerator Fund, a non-profit fund promoting affordable housing financing tools for black and brown businesses.
